CHRISTIAN LEGAL SOCIETY WELCOMES THE NOMINATION OF A TESTED FRIEND OF RELIGIOUS FREEDOM, JUDGE BRETT KAVANAUGH

"Judge Kavanaugh's private life further demonstrates that he understands and values the important role that religious organizations play in American society as they minister to the needs of the most vulnerable in their communities," explained Kim Colby, director of Christian Legal Society's Center for Law and Religious Freedom.

Christian Legal Society (CLS) welcomes the nomination of a tested friend of religious freedom, Judge Brett Kavanaugh, to serve on the United States Supreme Court. As our Nation celebrates the 25th Anniversary of the passage of the Religious Freedom Restoration Act of 1993, it is particularly fitting that a Supreme Court nominee be someone who has demonstrated a keen appreciation for the importance of its role in protecting all Americans' religious freedom.

Judge Kavanaugh has demonstrated a real commitment to protecting citizens' religious speech. CLS' Center for Law and Religious Freedom's primary focus for four decades has been to safeguard all Americans' right to express their religious beliefs and values in the public square. Adding yet another strong voice for freedom of speech to the Supreme Court is a very positive development.
