Colorado

Connecticut

Attorneys may claim credit for attendance at CLE programs approved by any bar association or state MCLE board.

Delaware

New York is a 50-minute state, and the credit hours are rounded down to the nearest half hour.

North Carolina

This course has been approved for 16.25 hours, including 5.5 hours of ethics and 1.5 hours of substance abuse/mental health (*Lawyer Well-being*).

North Dakota

Courses sponsored by state bar associations or a CLE body of a state with mandatory CLE are presumptively approved.
