Colorado

Attorneys may claim credit for courses approved by another CLE state. Colorado is a 50-minute state. Divide total minutes by 50; round general credits to nearest whole hour and ethics credits down to nearest tenth.

Connecticut

Attorneys may claim credit for attendance at CLE programs approved by any bar association or state MCLE board.

Delaware

Minnesota

Nevada

New Jersey

Attorneys taking courses approved for CLE by another state will receive 1:1 credit. New Jersey is a 50-minute state. Divide total minutes attended by 50; round down to nearest tenth of an hour.

New Mexico

Attorneys seeking CLE credit in New Mexico should apply on their own.

New York

For courses outside New York, attorneys may claim credit if accredited in the following states: Alabama, Arkansas, California, Delaware, Georgia, Indiana, Kansas, Kentucky, Louisiana, Mississippi, North Carolina, Ohio, Oklahoma, Oregon, Pennsylvania, South Carolina, Tennessee, Utah, Virginia, or Wisconsin. New York is a 50-minute state, and the credit hours are rounded down to the nearest half hour.

North Carolina

This course has been approved for 13.25 hours, including 4.75 hours of ethics.

North Dakota

Courses sponsored by state bar associations or a CLE body of a state with mandatory CLE are presumptively approved.

Ohio
